- Underlying Structure (Single/Multi)
- Time to Maturity
- Product Features (Quanto, Issuer Callability, ...)

Independent Valuation Process Flow

This graph illustrates the simple six-step-process of requesting and receiving independent valuations through the CONNEXOR API.

1. Subscription Request: 3. Subscription Confirmation: 5. 2. Coverage Check and Offering:

- CONNEXOR API conducts an automated coverage check:
 - Checks product availability within CONNEXOR universe.
 - Verifies payoff availability.
 - Ensures availability of market data for related underlyings.
- System generates an offering based on the coverage check:
 - Provides a quote for valuation based on product complexity.
 - User confirms acceptance of the quote.

4. End-of-Day Valuation:

- CONNEXOR API conducts end-of-day valuation:
 - Calculates net present value (NPV) for composite bond and option.
 - Determines delta and other sensitivities
- Valuation results are generated

6. Delivery of Valuation:

- Independent valuation results are delivered to the user.
- User receives comprehensive valuation report.
